Re: Letter of Permission (LOP), Holiday Decorations, Activities within the State's Shore Protection Act Jurisdiction, South Beach Parking Lot at the Atlantic Ocean, City of Tybee Island, Chatham County, Georgia.

Dear Mr. Gillen:

This letter is in response to your request to install a live evergreen tree seaward of the roundabout on Tybee Island, Georgia. The temporary project within the State's Shore Protection Act (SPA) Jurisdiction will begin no sooner 15 days from the date of this letter and be completed January 31, 2018.

As proposed, your request includes the use of a backhoe to excavate a 5ft. x 5ft. hole immediately landward and north of the 16th Street dune crossover. A 24ft. tall evergreen tree will be placed in the hole and backfilled. Unused excavated sand will be contained and stored at a location off site. Electricity will be supplied to the tree from a nearby source. The power cable will be identified and secured appropriately. A backhoe will be used to remove the tree no later than January 31, 2018. Previously excavated sand will be returned to the site and used to restore the location to pre-activity topographic conditions as determined by the Department.

The Department authorizes the temporary installation of the proposed amenities as depicted in the attached location map provided all Best Management Practices (BMPs) will be used to prevent any additional impacts at the site and to protect jurisdictional shore areas.

This Letter of Permission is not meant to exempt the above referenced activity from future environmental laws. No unauthorized equipment, materials or debris may be placed, disposed of, or stored in jurisdictional areas. Any incidental impacts associated with this project must be rectified by fully restoring areas to their pre-construction topographic and vegetative states.

This LOP is valid for the above referenced project. Any change in the use, location, dimensions, or configuration of the approved project, without prior notification and approval from this office could result on the revocation of this permission and in the required removal of the materials and related structures. This project must comply with all other Federal, State, and local statutes, ordinances and regulations.

Please accept this as our request for an LOP to install a live evergreen tree seaward of the roundabout on Tybee Island, Georgia. The purpose of the project is to have a live tree in the heart of the South end District for Tybee for the holidays. The estimate of the tree size is 24 feet.
