**RE: Letter of Permission (LOP), Temporary Activities in the State's Coastal Marshlands Protection Act Jurisdiction, Lazaretto Creek Boat Ramp, Lazaretto Creek, Chatham County, Georgia**

Dear Ms. Harte:

This LOP is in response to your request for authorization to maintain existing *No Wake* signs associated with the public boat ramp and service dock on Lazaretto Creek, Chatham County. As proposed, as many as four (4) piles will be pulled and replaced. The set of pilings west of the ramp is located at approximately 32.014457, -80.890274. The set of pilings east of the ramp is located at approximately 32.016321, -80.892380. Each set of piles supports a single 8'x 8' *No Wake* sign. The location of the signs is approximately 500 feet from the approach to the public facility on Lazaretto Creek, Chatham County, Georgia. The project will begin no sooner than 15 days after the date on this letter and be completed within 6 months of this letter's issuance.

The Department authorizes the replacement of the existing pilings as depicted in the attached description. No unauthorized equipment, materials, or debris may be placed in, disposed of, or stored in marsh jurisdictional areas. All portions of the structure that are removed must be disposed of at an appropriate upland disposal site. Any change in the use, location, dimensions, or configuration of the approved project, without prior notification and approval from this office, could result in revocation of this approval and may require removal of the materials and related structures.

This authorization does not relieve you from obtaining any other required federal, state, or local permits. Tidal water bottoms and marshlands of coastal Georgia are public trust lands controlled by the State, except for such lands where a validated Crown Grant or State Grant exists. The construction of the project must be completed within 6 months from the date of issuance of the LOP. Future maintenance activities that occur within tidal waters and have the potential to cause adverse impact, either temporary or permanent, or that will not be in the public's interest shall be reported to the Georgia Department of Natural Resources' Coastal Resources Division.
