Re: Letter of Permission (LOP), for Temporary Activities Associated with Tree Removal, 1100 Beachview Drive B, St. Simons Island, Glynn County, Georgia. GPS: (31.13746°N, 81.382006°W)

Dear Mr. Daniel:

This Letter of Permission (LOP) is in response to your request, received June 01, 2019, to remove three (3) trees within Shore Protection Act (SPA) jurisdiction that have died due to stress and flooding from Hurricane's Matthew and Irma. According to the request, the tree(s) will be removed using a chain saw and manual labor. When needed, underbrush may be trimmed to allow access to the dead trees identified in the request. All debris will be transported upland by hand and disposed of accordingly. Tree removal will begin no sooner than 15 days from the date of this letter and will be completed no later than six (6) months from the date of this letter.

The Department authorizes tree and underbrush debris removal as depicted in the attached description. No unauthorized equipment, vehicles, materials, or debris may be placed, disposed of, or stored in jurisdictional areas. Any incidental damage to dunes or dune vegetation will require restoration to be coordinated through this office. This LOP is valid for the above referenced project. Any change in the use, location, dimensions, or configuration of the approved project, without prior notification and approval from this office could result in the revocation of this permission and in the required removal of the related structures.

This LOP does not relieve you from obtaining any other required federal, state, or local permits. If you have any further questions or concerns regarding this or any other projects, please feel free to contact Amy Flowers at (912) 262-3109.

Hello Josh,

Per our phone conversation, there are some dead trees on the property of 1100 Beachview DR B, Saint Simons Island, GA 31522. We would like to remove them by cutting down even with the ground using a chain saw and manual labor. The trees were stressed by Hurricane Matthew, then hit again by flooding from Hurricane Irma, from which they never recovered.

There is some underbrush that will need trimmed as well so as to access the base of the trees.

Working on this by hand, may require several days to accomplish the task.

We would like to get started ASAP due to the heat index climbing up as the summer progresses.
