**Re: Letter of Permission (LOP) for Removal of Debris in Coastal Marshlands, T Street Landfill, Academy Creek Marshes, Glynn County, Georgia.**

Dear Mr. Alberson, Ms. Betts, and Mr. Hassett:

This Letter of Permission (LOP) is in response to your request on behalf of The Brunswick T Street Landfill Steering Group, dated May 29, 2020, to remove assorted debris from Coastal Marshlands Protection Act jurisdictional areas identified in a letter dated February 25, 2020 titled "*Marsh Line Survey and Debris Assessment Report, Former T Street Landfill, Brunswick, Georgia, Wood Project 6123191266*" (The Report). The Report identified two (2) areas, labeled as Area 14 and Area 15, that will require equipment to enter the marsh on temporary construction matting. Table 1 of The Report describes the debris at Area 14 as "metal car parts, tires, and mixed solid waste (MSW) and the debris at Area 15 as "metal and MSW." The removal of debris at all the other sites described in The Report will be conducted from the upland. The work will begin no sooner than fifteen days from the date of this letter and be completed within six months. The project is anticipated to have a duration of approximately twelve (12) weeks.

The Department authorizes debris removal as described in the attached description and illustrations. No unauthorized equipment, materials or debris may be placed, disposed of, or stored in jurisdictional areas. Any change in the use, location, dimensions, or configuration of the approved project, without prior notification and approval from this office, could result in revocation of this permission.

This authorization does not relieve you from obtaining any other required federal, state, or local permits. Tidal water bottoms and marshlands of coastal Georgia are public trust lands controlled by the State, except for such lands where a validated Crown Grant or State Grant exists.
