Potential GADNR Rule Changes

Official Code of Georgia Annotated (O.C.G.A.)

Title 27 Game & Fish (primarily license fees, penalties & comm)

Changes occur through legislation

Authorizes Board to promulgate rules & regs for fishing

Rules & Regulations of the State of Georgia

Title 391 Rules of Georgia Department of Natural Resources

Chapter 391-2-4 "Saltwater Fishing Regulations" authorizes

- Board of Natural Resources with 18 Sections of regulations
- e.g., eel, shad, shrimp, crab, rec & comm fishing
- Process of "Rule Making" includes public notice & Board action with GADNR Board meeting monthly



Atlantic States Marine Fisheries Commission

- Partnership of 15 Atlantic coast states
- Works for the conservation & management of shared near shore fishery resources (0-3 miles)

Bluefish Coastal assessment: stock is overfished



States have 2 options

- Adopt coastwide ASMFC measures: 3-fish rec and 5-fish for-hire creel
- Offer "Conservation Equivalency" option: allows states flexibility to develop alternate regulations still achieve coastal objectives
 - Required GA decrease in coastwide rec harvest = 8.13%
 - Achieve estimated 13.1% decrease by closing March & April harvest (2020 & 2021)

CRD has decided to continue to annually close March & April via Administrative Order by DNR Commissioner rather than codify through Board Rule.



South Atlantic Fishery Management Council

- Conservation & management of stocks 3-200 miles offshore
- Proposed rule changes are sent to NMFS for review & final approval by Secretary of Commerce

Dolphin (federal waters)

- Sept 2021 Council meeting: amendment for <u>proposed</u> rule being prepared for submission to NMFS
- Decrease vessel creel limit for rec and charter vessels from 60 to 54 fish
- Individual creel limit 10 per person or 54 per vessel, whichever is less

Current Georgia state water dolphin regulations: 10 per person not to exceed 60 per boat.

If approved by NMFS, recommend state regs changed through Board Rule to match federal. Estimated impact: <0.1% of Georgia angler trips.





- Most federal water species are managed through Councils
- HMS species found throughout Atlantic, GOM & Caribbean and thus NOAA has primary management authority (HMS Management Division)
- Strictly managed with required rec & charter vessel permit & reporting
- In addition to minimum sizes, annual US landings limit of 250 Atlantic blue marlin, white marlin & roundscale spearfish (combined).

Current GA Board Rule for sailfish, blue & white marlin:

"No open season has been established by the Board of Natural Resources."

CRD recommends state regs changed through Board Rule

- Match federal minimum sizes
 - 63-inch, 99-inch & 66-inch LJFL (respectively)
- Season: only open when allowed by applicable federal law



Sometimes inquiries lead to recommended changes

- Current GA Tarpon regs = minimum 68" FL allows for possible record landing
- Primarily catch & release with anglers seeking photos holding fish prior to release
- Being lifted from the water can reduce ability to survive
 - Damage to jaw and gills
 - If lifted into boat, easy to drop when fish "kicks"
 - Intense innate fight when caught & leads to oxygen depletion, often severe

Recommend add to Board Rule

"Tarpon over 40-inch fork length must remain in the water at all times,

with gear limited to hook and line, and no gaffing."

Gulf and South Atlantic Regional Panel on Aquatic Invasive Species

"A certain percentage of non-native species, introduced either intentionally or unintentionally, have harmful or damaging effects on the ecosystem that is invaded, causing extensive changes to the native vegetation (plants), wildlife, and the habitat."

Angler & Guide Satisfaction Survey

2017 survey GA licensed residents: 1,965 anglers and 83 guides (62%)

- Anglers: SIP permit holders who saltwater fished in previous 12 months
- 171-page report includes survey questions & summary of results
- Responses from anglers and guides presented separately

2022 survey

- ~85% of 2017 survey questions will be repeated verbatim
 - New aspect is comparison between 2017 & 2022 responses
- New questions relate primarily to opinions related to flounder & sheepshead
 - Red Drum specific: circle hook use, if yes, short leader circle hook use
 - Nighttime fishing
 - Flounder specific: what fishing method(s) used
- Deleted questions:
 - General CRD questions: focused on Marine Fisheries
 - Offshore & artificial reef use questions: focused on 4 marine finfish species

Angler & Guide Satisfaction Survey

Question template: red drum, spotted seatrout, flounder & sheepshead

Do you typically fish for (species) in Georgia? (remainder of species-specific questions are only asked if reply = yes)




Red Drum Updates 2021




