**Re: Letter of Permission, Temporary Activities, Placement of Fourth of July Fireworks Display, Ocean Forest Golf Club, Sea Island, Atlantic Ocean, Georgia

Dear Ms. Heins:

This Letter of Permission (LOP) is in response to your request, dated November 13, 2018, to set up equipment for a 4<sup>th</sup> of July fireworks display held by Sea Island Acquisitions within Shore Protection Act (SPA) jurisdiction.

The fireworks set up, display, and removal will occur on July 4, 2019 at the Ocean Forest Golf Club beach on Sea Island. The equipment required includes a Jeep and trailer that will access the beach via a designated beach access point for motor vehicles at 36<sup>th</sup> Street to deliver and remove the firework display. The trailer will be the launch area for the fireworks display and will be staged landward of the ordinary high-water mark and seaward of the dunes in an un-vegetated area. The fireworks display will begin at approximately 9:00 PM. According to the request, all materials will be removed by the end of the day on July 4, 2019 after the fireworks display.

The Department authorizes the placement of the firework setup equipment as depicted in the attached description and site map, and has no objection to the action, provided Best Management Practices (BMP's) are used. **No unauthorized equipment, materials or debris may be placed, disposed of, or stored in jurisdictional areas.** Any incidental damage to dunes or dune vegetation will require restoration to be coordinated through this office. This LOP is valid for the above referenced project. Any change in the use, location, dimensions, or configuration of the approved project, without prior notification and approval from this office could result on the revocation of this permission and in the required removal of the related structures. Because the project occurs between May 1<sup>st</sup> and October 31<sup>st</sup>, turtle nesting season, an individual with a DNR Sea Turtle Cooperators Permit needs to survey the area prior to the work beginning.

This LOP does not relieve you from obtaining any other federal, state, or local permits. If you have any further questions or concerns in regards to this or any other projects, please feel free to contact Josh Noble at (912) 264-7218.

- The removal of the trailer after the fireworks display, 7/4/19.

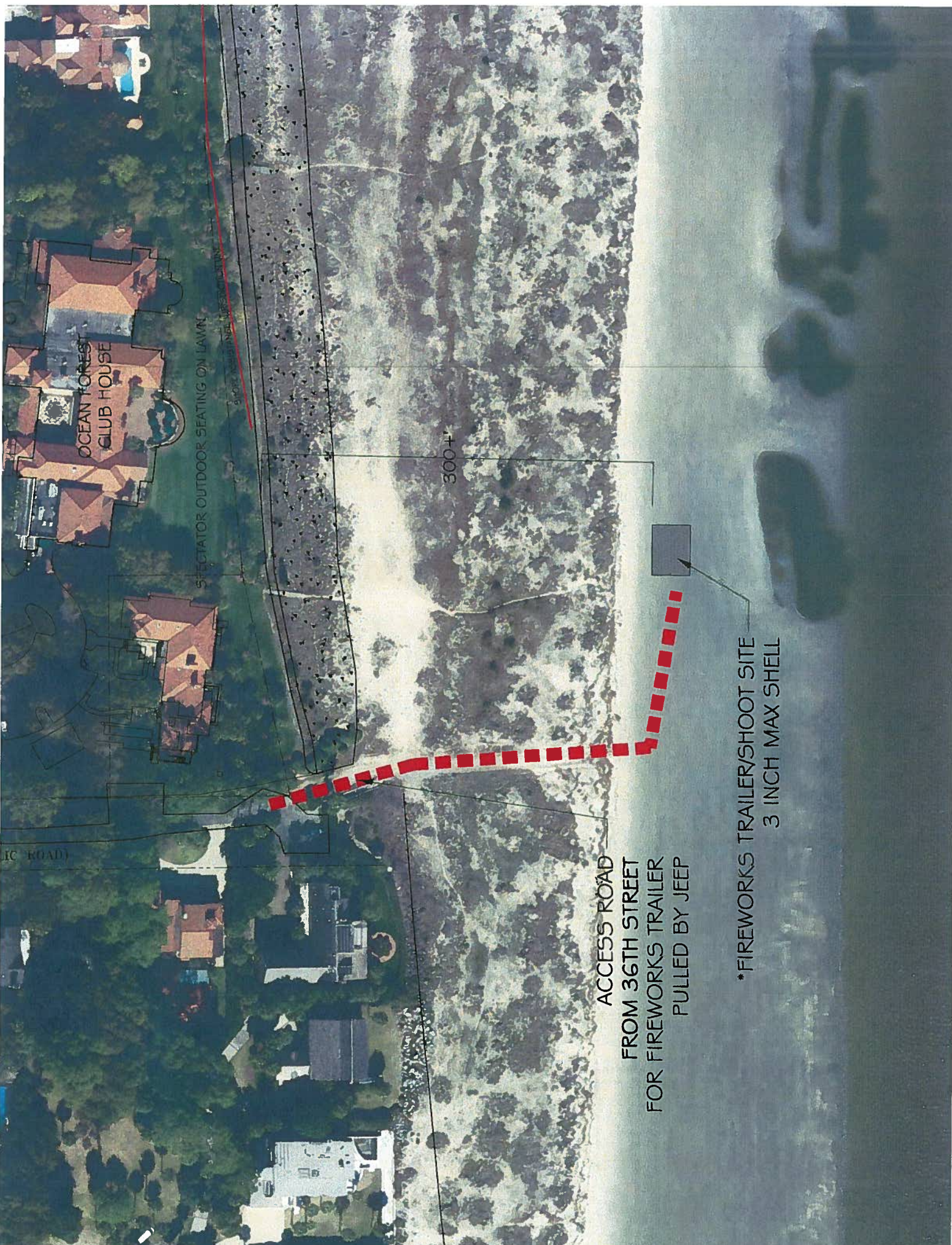
