The October 28, 2014 meeting of the Law Enforcement Committee was called to order by Chairman Philip Wilheit.

Chairman Wilheit called on Dr. Philip Watt, Chairman of the Law Enforcement Committee.

Chairman Watt called on Major Stephen Adams who briefed the committee on DNR's All Disaster Response Manual.

Major Adams stated DNR has unique equipment, facilities and employees with skill sets that can cooperatively work with other state agencies in support of local governments when disasters strike. He further stated the Disaster Response Manual was revised in 2014 by multi-divisional employees and encompasses all DNR response capabilities. He added the manual contents include deployment procedures, role of the Law Enforcement Division, roles of the Wildlife Resources Division and Parks Division, and the DNR Hurricane Plan.

Chairman Watt called on Captain Mike England who briefed the committee on the Boating Violator Compact.

Captain England stated the Boating Violator Compact is a voluntary interstate agreement which provides participating states with a mechanism to participate in a reciprocal program to promote compliance with the statutes, laws, administrative rules and regulations relating to boating safety in their respective states and provide for the fair and impartial treatment of boating violators within the participating states.

Captain England stated the Boating Compact parallels the process related to Driver's License Compact and suspensions pursuant to Title 40 and the Interstate Wildlife Violators Compact pursuant to Title 27. He further stated HB 777 was passed in the 2014 legislative session which enacts the Interstate Boating Violator Compact. He added HB 777 was signed into law by Governor Deal on April 23, 2014.

Captain England stated three public meetings will be held in November and all written submissions must be postmarked by November 28, 2014. He further stated LED anticipates presenting the proposed rule to the full Board in January 2015.

Mr. Johnson stated the people of Augusta were thankful for this compact and thanked Captain England for his work on this rule.

The October 28, 2014 meeting of the Wildlife Resources Committee was called to order by Chairman Philip Wilheit.

Chairman Wilheit called on Mark Mobley, Chairman of the Wildlife Resources Committee, who called on John Bowers, Chief of Game Management, to give the Board an overview of the 2015-2024 Deer Management Plan.

Mr. Bowers stated the current ten-year plan ends in 2014. He further stated the process for creating the new Deer Management Plan began approximately 18 months ago.

Mr. Bowers stated that there are four levels of public involvement in the planning process: stakeholder steering committee, 4 regional stakeholder subcommittees, public input opportunities, and scientific survey of public opinion.

Mr. Bowers explained the ten key issues for deer management which includes deer seasons, deer bag limits, hunting methods and equipment, deer management techniques, deer density, deer conflict management, education and outreach, privatization of wildlife, hunter access and miscellaneous issues.

Mr. Leebern asked if WRD receives input from DNR Law Enforcement during the planning process. Mr. Bowers stated WRD does receive input from LED.

Mr. Davis asked Mr. Bowers if counties can place restrictions on deer antler sizes. Mr. Bowers stated counties could request for WRD to make these changes in their regulations. Discussion ensued on this topic.

Dr. Watt stated he would like to see youth hunting opportunities improve.

Mr. McWhorter discussed the definition of a primitive weapon. Mr. Bowers stated some states use very detailed restrictions, but Georgia does not.

Discussion ensued concerning mandatory tagging of deer. Mr. Bowers stated the use of electronic reporting will allow WRD to gain useful research information.

Mr. Stewart asked Mr. Bowers if WRD kept track of the number of deer killed by car accidents. Mr. Bowers stated DOT keeps this information and it is estimated to be 50,000-52,000 deer killed annually by vehicles.

The October 28, 2014 meeting of the Environmental Protection Committee was called to order by Chairman Philip Wilheit.

Chairman Wilheit called on Ray Lambert, Chairman of the Environmental Protection Committee.

Chairman Lambert requested there be an amendment to the Agenda. He stated the purpose of the amendment would be to add "Item F" under Tab C. He further stated "Item F" would be a briefing on the proposed Waters of the U.S. Rule to be presented by Directory Turner.

Chairman Lambert called for a motion to amend the Agenda by adding "Item F" under Tab C.

A motion was made by Ms. Johnson, seconded by Mr. McWhorter and carried unanimously to amend the agenda.

Chairman Lambert stated the amendment to the Agenda must be approved by the Board of Natural Resources.

Chairman Lambert requested Chairman Wilheit adjourn the Environmental Protection Committee.

The meeting of the Environmental Protection Committee was temporarily adjourned by Chairman Lambert so that the Board of Natural Resources could vote on the amendment of the agenda.

The meeting of the Environmental Protection Committee was reconvened by Chairman Wilheit, who called on Chairman Lambert.

Chairman Lambert called on Keith Bentley, Chief of the Air Protection Branch, to present the proposed Grant Criteria for Georgia Diesel Emissions Reduction Program.

Mr. Bentley stated the purpose of this grant is to reduce particulate emissions by assisting public school systems with school bus replacements. He further stated the grant is funded by the Environmental Protection Agency and the National Clean Diesel Campaign. He added the amount of funding currently available for this program is \$147,888.

Mr. Bentley requested the Committee recommend that the Board approve the item as presented.

A motion was made by Mr. Hudson, seconded by Mr. McWhorter and carried unanimously that the Committee recommend that the Board approve the proposed Grant Criteria for Georgia Diesel Emissions Reduction Program, Chapter 391-3-21-.15, as presented.

Mr. Bentley stated the next item would be a briefing on the proposed amendments to the Rules for Air Quality Control, pertaining to the Removal of Fine Particulate Matter Nonattainment New Source Review Requirements.

Mr. Bentley stated the purpose of this revision is to remove the nonattainment permitting requirements for the Macon Area (Bibb County and a portion of Monroe County) and for Floyd County, as these two areas have been designated from nonattainment to attainment for the fine particulate matter ambient air quality standard. He further stated the revision will reduce the administrative burden to EPD and will reduce costs to major industrial sources and utilities that wish to locate or expand in these areas.

Mr. Bentley stated a public hearing will be held in December 2014. He further stated EPD anticipates requesting adoption of this Rule from the Board in January 2015.

Chairman Lambert stated the information for Item C (Proposed Amendments to the Rules for Radioactive Materials, Chapter 391-3-17, pertaining to miscellaneous changes and updates) could be found in the board package. He further stated the proposed amendments are clarifications and/or routine updates necessary to address requirements of the U.S. Nuclear Regulatory Commission for Agreement states. He added no presentation is planned for this agenda item and Mr. Bentley will be available to answer any questions you have about these materials.

Chairman Lambert called on Bert Langley, Director of Compliance, who gave an informative presentation on EPD's District Offices and Emergency Response Team.

Ms. Johnson thanked Mr. Langley for his presentation.

Discussion ensued on the disposal and uses of scrap tires collected by EPD.

Chairman Lambert called on Russ Pennington, EPD Director of Policy and Public Affairs, who updated the Board on the Aquifer Storage and Recovery Pilot Project.

Mr. Pennington stated the project calls for withdrawing water from the Floridan Aquifer when water is plentiful and pumping it deeper into the ground into the Claiborne and Clayton Aquifers. He further stated the drill rig is now on site and coring samples have been taken. He also discussed the ASR project schedule timeline.

Discussion ensued about the ASR pilot project.
