**SUBJECT:** Hunter Education Requirement for Applicants

---

When completing the enclosed One-Time Veteran's Hunting and Fishing License application, pay special attention to the Hunter Education requirement. If you are born after January 1, 1961, and are age 16 or older, you must provide your Hunter Education number on the application to receive a license. If you remember taking Hunter Education in Georgia but cannot provide your Georgia Hunter Education number on the application, complete the enclosed Hunter Safety Certification Affidavit, and submit the Affidavit with the application. This will significantly reduce the processing time of your application.

Create a Go Outdoors Georgia account profile at <https://www.gooutdoorsgeorgia.com/> or by calling 1-800-366-2661. **If you do not have a Go Outdoors Georgia account, you are required to enter your full Social Security Number below.** While online, you may bypass using this application form by completing a Customer Application to certify your eligibility. Once approved by licensing personnel, you may purchase your no cost license online or by calling 1-800-366-2661. **Hunter Education is required if born after January 1, 1961. Only a fishing license will be issued without a hunter education number if born after January 1, 1961. If you want both hunting and fishing privileges, do not apply until completing the hunter safety course.**

**Warning:** A person who knowingly and willfully makes a false, fictitious, or fraudulent statement or entry, in any matter within the jurisdiction of any department or agency of state government shall, upon conviction thereof, be punished by a fine of not more than \$1,000.00 or by imprisonment for not less than one nor more than five years, or both (Georgia Law 16-10-20). I affirm that the statement that I am submitting is true and complete.

**General Information**

- Applicants for the One Time Veteran's License must be military veterans who meet all the following criteria:
  - Have not previously received this license.
  - Served on active Federal duty for 90 or more days.
  - Discharge date is July 1, 2005, or later (veterans discharged before July 1, 2005, are not eligible for this license).
  - Currently reside in Georgia and have submitted one of the following documents as proof of residency: valid Georgia Driver's License or valid State of Georgia ID Card.
- The One Time Veteran's License will be valid for 12 months from the date of issue.
- The One Time Veteran's Hunting and Fishing License covers all recreational hunting and fishing licenses (except Federal Duck Stamp). This specifically includes Hunting, Fishing, Trout, Big Game, WMA, GA Waterfowl Conservation and Alligator licenses. It does not include commercial licenses. Additional free annual licenses or permits may be required for certain activities: no charge Big Game Harvest Record to hunt deer, bear, and turkey, no charge Georgia Migratory Bird Stamp to hunt migratory birds, no charge SIP permit for saltwater fishing, no charge deer-dog hunting license, and quota permit to harvest an alligator.
- Applicants without hunter education that were born after January 1, 1961, may request a One Time Veteran's Fishing License (fishing only). If the applicant wants the One Time Veteran's Hunting and Fishing License that includes both privileges, they should not apply until completing the hunter safety course. Applicants must initial the application in the space provided to receive a One Time Veteran's Fishing License and waive the right to a One Time Veteran's Hunting and Fishing License.

**Instructions**

- Complete the application.
- Attach a copy of your DD Form 214 (ETS must be after June 30, 2005), and a copy of proof of residency.
- Mail the application, a copy of DD Form 214, AND a copy of proof of residency to:

- Allow 21 days to process your license. Your sportsman's privileges are not valid until you receive your license. If you provide an email address on this application, you will receive an emailed copy of your license.
