Regulatory Objectives

- Biologically Appropriate & Scientifically Sound
- Responsive to Public Desires within Biological Appropriateness
- Strive for Simplicity & Flexibility
- Minimize challenges for Recruitment, Retention & Reactivation (R³)

Major Changes – Legislative (HB 1147)

- Rules governing hunting and fishing are either **statutory** (state law) or **regulatory**. State laws are passed by the legislature. Regulations are passed by the Board of Natural Resources within statutory authority.
- HB 1147 was passed by the legislature during the 2022 session and the affected DNR Rules were amended accordingly in time to take effect July 2022.



Hunting & Trapping, Private Lands

- Effective July 1, 2022, there is no closed season nor any bag limit for raccoons and opossums
- All methods currently lawful for take of these species may be used, including hounds
- All other regulations and license requirements do still apply



Public lands - Hunting

- On WMAs, we expanded hunting opportunity 61 additional days
- Now the season is **Aug 15 Feb 28** (closed during quota hunts and unless otherwise specified)
- No bag limit
- All other public land license requirements and restrictions will still apply



Public lands - Trapping

- On WMAs, trapping is by permit only
- Albany Nursery, B.F. Grant, Big Lazer Creek, Blanton Creek, Bullard Creek, Clayhole, Pigeon Mountain, Dawson Forest, Dixon Memorial, Elmodel, Joe Kurz, Penholoway, Rum Creek, Tuckahoe, West Point, and Yuchi

Major Changes – Legislative (HB 1148)

- HB 1148 was also passed by the legislature during the 2022 session and the affected DNR Rules were amended accordingly in time to take effect July 2022.
- This bill made it unlawful to bring an intact deer carcass into GA from any other state (not just those with reported cases of Chronic Wasting Disease).



Proposed Changes – Statewide Regulations

- Housekeeping (minor changes to existing rules to correct errors or omissions, or to clarify)
 - For drawn big game quota hunts, a hunter may bring an assistant afield
 - Clarify alligator hunters can sell a lawfully harvested raw hide
- **Alligators** add 100 harvest permits (increases total quota to 1,130).
- Extended Archery Season (Urban Counties) Add Richmond to those counties with an extended archery season consistent with the Statewide Strategic Deer Management Plan 2019-2024.

Proposed Changes – Deer Season SWGA

- 1st 2 weeks of archery buck only due to late fawn weaning
- Extend firearms season to January 15th
- Extend archery season to January 31st (maximum statutory framework)
- Data from does recently collected in SW GA show peak rut is later than other areas of the state

Baker, Decatur, Early, Grady, Miller, Mitchell, Seminole, Thomas Counties



Proposed Changes – Bears

- Require Game Check for all 3 zones
- Allow northern zone hunters to get harvested bears tagged by participating taxidermists and meat processors as well as usual locations
- Stipulate that bears harvested in the southern zone must be taken for tagging within 24 hours of harvest



Proposed Changes – Central Bear Zone

- Allow an additional day of opportunity if less than 6 females are killed on 1st day
- Upcoming season date is Dec 16, 2023; the second day would be Jan. 6, 2024 if <6 sows taken on Dec 16
- Keeps current 3rd Saturday in December single day private land only hunt as is
- Allows additional opportunity, particularly if weather on Day 1 restricts harvest, while limiting the risk of overharvesting females on Day 2
- UGA Population Viability Analysis annual mortality above 11 adult females would result in pop'n decline over time
